Parish Road Sulphur, LA 70663 Tuesday, January 21, 2025 rescheduled for Tuesday, January 28, 2025 @ 5:30 PM

The Board of Commissioners of Sulphur Parks and Recreation (SPAR) met at 5:30 pm on Thursday, January 28, 2025 in the multipurpose room at SPAR Recreation & Aquatic Center in Sulphur, Louisiana for a regular schedule board meeting. The meeting was call to order and a roll call was taken. Board members present were Don Martin, Mike Boyette, Len Lemelle, and David Couvillon. David Devall was absent.

Following nominations and acceptance, Mr. Len Lemelle was installed as Board President and Mr. Don Martin was installed as Board Vice President for 2025 on a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried. (Tabled by Board at the Dec. 17, 2024, regular meeting)

On a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried, the board approved minutes as presented for the December 19, 2024, regular board meeting.

Staff notified board that financial statements for December 2024 would be presented at the February 2025 board meeting to allow additional time to complete year end closeout.

The board, on a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried following unanimous roll call vote, adopted a resolution approving the Louisiana Compliance Questionnaire as required by Louisiana Legislative Auditor in connection with Sulphur Parks and Recreation's financial audit for FY-2024.

A resolution authorizing Laurie Koelzer, Executive Director of Sulphur Parks and Recreation, to submit and execute cooperative endeavor grant funding opportunities as provided for by the Calcasieu Parish Police Jury, with board to be notified of agreements, was adopted following a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried.

On a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried, staff was granted permission to pursue grant opportunities as they become available with vendors and/or agencies that provide products or services that align with SPAR's needs. Staff will present it to the board for final approval prior to entering into grant funding agreements.

Following open discussion, board elected to table agenda item on a motion by Mr. Martin, seconded by Mr. Boyette, to be re-visited at the February 2025 board meeting. The staff recommended acceptance of the low public bid received and opened on January 23, 2025, for an Enclosed Softball Batting Cage and Locker Room Building to be located at North Frasch Softball Complex received from Pat Williams Construction in the amount of \$1,272,000. Construction time is estimated to be 270 calendar days after issuance of notice to proceed.
