TERMS OF MEMBERSHIP

- ✓ This agreement represents the complete understanding between the Member and Sulphur Parks and Recreation (SPAR). No representations, written or oral, other than those contained within this agreement are authorized by or binding upon SPAR.
- ✓ Membership to the Frasch Park Golf Course is nontransferable and nonrefundable, except in the case of major health condition, job transfer from the area, or death on a pro-rated basis in the first half of the membership term less a \$25 transaction fee. Any refund is subject to verification and must be approved by Administration.
- ✓ Membership fees are not based on frequency of use.
- ✓ Membership rates are subject to change. Notification of rate changes will be posted at the Frasch Park Golf Course.
- ✓ Annual and Semi-Annual memberships expire 365 days and 180 days respectively from date of purchase.
- ✓ Private and Fleet Cart Memberships are available for purchase by patrons with a valid driver's license.
- ✓ Members are liable for any damaged caused by member or use of cart to carts, property, and/or equipment.

PAYMENT INFORMATION

- ✓ Memberships may be paid for by cash, check, or credit card. Renewal of membership is at member's discretion.
- ✓ Should any member debt not be honored by the member's bank/depository for any reason, the member is still responsible for that payment plus a service charge applied by SPAR. The membership is subject to suspension until debt is paid.

STATEMENT OF AGREEMENT

- ✓ Frasch Park Golf Course may close or offer modified hours on holidays such as, but not limited to, New Year's Day, Easter, Thanksgiving, Christmas, or other.
- ✓ SPAR may close certain areas and/or whole facility for special events, emergency situations, maintenance, etc. Advance notice will be provided for scheduled closures.
- ✓ Solicitation is not permitted on Sulphur Parks and Recreation property.
- ✓ I authorize the use of my likeness in photo, video or other to promote Sulphur Parks and Recreation.

HOLD HARMLESS CLAUSE

Private Cart Membership Agreement

Frasch Park Golf Course allows the purchase of a membership to include the use of a private cart to be stored within the Frasch Park Golf Course cart storage shed. The owner of private cart agrees to hold management free from liability in the event of loss of fire, theft, damage, vandalism or other claims during the term of the agreement. Owners of private golf carts will be responsible for any damage to golf course property or other property, equipment, or individuals from any cause whatsoever involving their carts. The above damage liability exclusions include the golf course premises, in the cart shed, and/or any park related property. Private cart owners are encouraged to obtain adequate insurance to cover the equipment and liability. Private cart membership does not include maintenance of any type on golf carts. Private cart owners are responsible for arranging maintenance of their carts through private businesses and are discouraged from attempting to use SPAR employees. Private carts will not be permitted on the course when fleet carts are not permitted on the course due to course or weather conditions. Private cart owners are responsible for keeping their assigned storage area and carts clean of debris and old batteries, as well insuring that batteries do not leak. The assigned storage area is for carts only; no extra equipment, supplies, boxes, etc. may be kept in the storage area. Carts and storage areas not maintained in a clean and orderly manner as determined by SPAR may be subject to membership revocation and being required to remove private cart from SPAR premises.

Cart Storage and Use Rules: Frasch Park Golf Course encourages Private Cart Members to carefully consider decisions about purchasing and/or investing in personal carts to be stationed at Frasch Park Golf Course. Future plans & developments might include major renovations of the ProShop & Grill. This could involve changes to first floor areas now being utilized for cart storage. There are no current plans to eliminate the private cart membership but we feel that you should think carefully about decisions involving your golf carts; as, due to space and/or construction, the membership may be modified or temporarily interrupted. Our goal would be to provide a one year notice of any major changes such as mentioned.

1. **Private Cart Memberships are available for purchase by patrons with a valid driver's license.**
2. Memberships are non-transferable.
3. Private cart members must use his or her own cart. The cart can only be used by the owner, spouse and/or children who are members listed on the private cart membership. Children must be family dependents of primary members, 22 years old or younger and a full-time student. Private carts cannot be borrowed without written permission from owner of cart, payment of a borrowed cart fee, and a signed borrowed cart use agreement.
4. Refunds are available in the case of major health condition, job transfer from the area, or death on a pro-rated basis in the first half of the membership term less a \$25 transaction fee. Any refund is subject to verification and must be approved by Administration. Carts must be removed from storage immediately in the event of a refund being issued.
5. No gas golf carts are allowed.
6. Payers and any registered family members (as defined on the rates sheet) who will be operating or riding in the cart may be required to present a picture identification card at the Pro Shop.

INSURANCE INFORMATION DISCLOSURE STATEMENT

The private cart owner agrees to hold SPAR free from liability in the event of loss by fire, theft, damage, vandalism or other claims during the term of the agreement. The private cart owner will be responsible for any damage to golf course property or other property, equipment, or individuals from any cause whatsoever involving their carts. The above damage liability exclusions include on the golf course premises, in the cart shed, and/or any park related property. Private cart members are encouraged to obtain adequate insurance to cover the equipment and liability.
