

SULPHUR PARKS AND RECREATION (SPAR) Regular Board of Commissioners Meeting Held at the SPAR Recreation and Aquatic Center Multipurpose Room 933 W. Parish Road, Sulphur, Louisiana 70663 Tuesday, October 15, 2024, 5:30 P.M.

The Board of Commissioners of Sulphur Parks and Recreation (SPAR) met at 5:30 pm on Tuesday, October 15, 2024, in the multipurpose room at SPAR Recreation and Aquatic Center in Sulphur, Louisiana for the regular scheduled board meeting. The meeting was called to order, and a roll call was taken. The board members present were Don Martin, Mike Boyette, David Devall, Len Lemelle, and David Couvillon.

Minutes from September 18, 2024, regular board meeting were approved as presented on a motion by Mr. Boyette, seconded by Mr. Couvillon, and carried.

Financial statements for September 2024 were approved as presented by the director, Ms. Koelzer, with all revenues and expenses as expected, on a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried. Ms. Koelzer stated that the amended budget would be presented in November.

Ms. Koelzer introduced the Athletics Manager, Mr. Billy Christian, to present staff proposed changes to the Sports and Facilities Manual. After discussion, the board accepted the changes as presented with minor modification. Changes were adopted effective January 2025, except for Basketball changes which were made effective immediately, on a motion by Mr. Martin, seconded by Mr. Couvillon, and carried. Key changes include: the addition of an out-of-district fee based registration option for youth athletes that do not reside within the SPAR District 2 of Ward 4 boundaries, all participants require proof of residence upon registration, converting senior leagues (older high school) from drafted teams to self-formed teams, addition of social media to the code of conduct and disciplinary procedures, expanded time frame from 3 days and 2 days to 7 days and 5 days respectively for member and non-member tee time reservations, and updates to tournament team registration allowing for non-district players to participate for a fee without restricting access to fields or amenities.

 - Center Circle Pool House & Pool Trahan Construction

- c) Approval received from the Louisiana Office of Community Development (OCD) for the Frasch Park Revitalization project for funding under the state's Community Development Block Grant – Disaster Recovery (CDBG-DR) program which would provide for 80/20 (CPPJ/SPAR) cost sharing. Calcasieu Parish Police Jury initiated and approved SPAR's application and submitted it to the State for approval. Next steps, application development to include engineering cost estimates.
 - Frasch Park Revitalization Inclusive playground/splashpad, hard surface inclusive field, restrooms, underground utilities, HVAC and insulate Gymnasium, Parking and Drainage Improvements Estimated cost is \$6 million.
- d) November 2024 SPAR Board meeting to include presentation, discussion, and consideration to amend the 2024 Financial Budget and presentation, discussion, and consideration to adopt the

2025 Financial Budget. Public Hearing will be conducted at 5:30 p.m.; followed by regular board meeting.

Regular session resumed at 7:14 PM following a motion by Mr. Devall, seconded by Mr. Couvillon, and carried.

On a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried the board voted to increase the director's compensation to \$144,000/year effective immediately.

All business taken care of, the motion to adjourn was made by Mr. Couvillon, seconded by Mr. Lemelle, and carried.

Meeting adjourned at 7:15 PM.
